#### **Contract Title: Packages of digital equipment for online learning in ROSE supported high-schools – videoconference cameras**

The *Government of Romania* has received financing from the World Bank toward the cost of the Romania Secondary Education Project, and intends to apply part of the proceeds toward payments under the contracts for *Packages of digital equipment for online learning in ROSE supported high-schools – videoconference cameras*.

The Ministry of Education and Research – Unit for the Management of Externally Financed Projects now invites sealed bids from eligible bidders for: Packages of digital equipment for online learning in ROSE supported high-schools – *videoconference cameras*, divided on 8 lots: Lot 1. Bucuresti Ilfov, Lot 2. Centru, Lot 3. Nord Est, Lot 4. Nord Vest, Lot 5. Sud, Lot 6. Sud Est, Lot 7. Sud Vest and Lot 8. Vest.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, Revised July 2014* ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest. The evaluation will be done on a lot by lot basis.

Late bids will be rejected.
